Executive Director Rick provided updates to the Minnesota Free Schools Meal Program report, Minnesota Senate Education Policy and Finance Committee visit, upcoming 2024 Capital Budget Presentation to the Executive Budget Team and Senate Capital Investment tour and presentation, the Minnesota Association of School Administrators Fall Conference, updates to the Douglas Drive/Highway 55 Project, labor negotiations between the State of Minnesota and State Residential Schools Education Association (SRSEA), and highlighted upcoming events.

Policy 534 School Meals Policy – Dr. Rick and Human Resources Director Ekpe Akpan provided an overview of the draft policy for Perpich Center for Arts Education's participation in the Federal School Nutrition Program.

Member P. Hustoles moved to approve Policy 534 School Meals Policy, Member Mohr seconded. Principal Bullen responded to guestions from Members Hustoles and Salazar.
